- 4. Those individuals or groups desiring information on the Pool Area should contact the pool at 758-8424.**
- 5. The Recreation Park facilities are for the use of all Town of Red Hook citizens. Please follow and practice all the common codes and principles of good conduct. Use good citizenship and common sense; respect others and the facilities.**
