

NOTICE OF PUBLIC HEARING
TOWN OF RED HOOK

The estimated annual cost of the maintenance and operation of the improvements within the Extension is \$945. The estimated annual cost of the Consolidated Lighting District, as proposed to be extended, to the typical property owner or, if different, to the typical one or two family home, would be \$41.31.
